This commitment to excellence ensures that all our qualifications whether regulated or non-regulated meet a high standard, reflecting our dedication to quality in all aspects of our work.

The combined 170+ years heritage and global footprint of the IAB and LCCI brands alone ensure that our qualifications are universally recognised in 30 countries.

Further enhancing the IAB Group's portfolio is the International Association of Accounting Professionals (IAAP), an organisation rooted in finance, dedicated to accrediting high-level professionals and offering non-regulated qualifications that mirror prevailing industry trends. Its overarching objective remains to equip finance professionals with the skills needed to progress and thrive in their careers, ensuring they remain ahead of the curve in today's competitive business landscape.

PDI, The Professional Development Institute has long-standing trading operations in educating the corporate and banking sector with a range of qualifications advancing to level 7. A testament to this reputation PDI has been appointed by the Institute of Banking Studies in Jordan to provide their members with qualifications. Qualification Regulation and Quality

The IAB Group offers both regulated and non-regulated qualifications to meet a variety of educational needs and market demands. A non-regulated qualification differs from a regulated qualification in that it does not adhere to the standards set by the Regulated Qualifications Framework (RQF) and lacks validation from an official industry body.

While non-regulated qualifications are valuable for personal and professional development, they are often not recognised by universities during the admissions process, unlike regulated qualifications. It is important to understand the distinction between the two within the educational landscape as it can impact individuals' opportunities for further academic pursuits and career progression.



Ofqual is a non-ministerial government department in England which has the regulatory authority for overseeing qualifications awarded by organisations such as the IAB and the LCCI. Ofqual plays a pivotal role in upholding the credibility of regulated certifications through its stringent monitoring and quality assurance procedures, and ensures that qualifications authentically mirror the knowledge, competencies, and comprehensions acquired by students.

By establishing rigorous criteria for assessments and examinations, Ofqual guarantees that these evaluations accurately highlight a student's accomplishments meaning individuals can have confidence in the certifications sanctioned by Ofqual, and in turn the awarding organisation, thereby upholding the integrity and reliability of the education and certification framework.

Having Ofqual accredited recognition provides confidence to qualification users that the awarding organisation has the capacity and competence to develop and offer high-quality qualifications. Certificates for Ofqual regulated qualifications can carry the Ofqual logo – a recognised quality mark across the world to universities and employers.

We are proud to have two organisations within the IAB Group that offer regulated qualifications, this by default naturally enhances the strength of our non-regulated offering. Our meticulous approach ensures that our development and review processes are consistently upheld, resulting in the delivery of qualifications at a high level of excellence across all group organisations. This dedication to excellence ensures that every qualification in our portfolio meets rigorous standards, reflecting our commitment to maintaining quality in all aspects of our operations.

The History of the IAB

The IAB was formed in 1973 by the Council of the Institute of Administrative Accountants (IAA). This was done to retain links with its bookkeeping history dating back to 1916.

The objective of the IAB was to offer basic qualifications in Bookkeeping at three levels, Preliminary, Intermediate and Final, with the final level being the equivalent to GCE A Level, a far cry from the breadth of qualifications now offered by the IAB Group today.

In September 2022, the International Association of Bookkeepers (IAB) changed its name to the Institute of Accountants and Bookkeepers (IAB). This change was made to reflect the diversity of our membership and our qualification offering.

In 2023 the IAB celebrated its 50th year, the name change, specifically the word 'Institute' endorses the heritage of the organisation and acknowledges the pioneering work that continues in education, Anti-money Laundering and the lobbying of legislation in government on behalf of the industry.

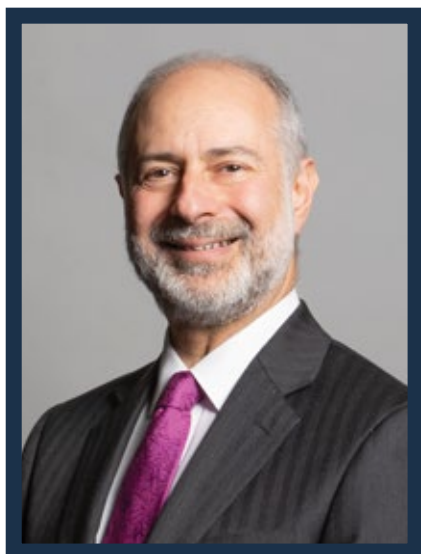

Outside of her ventures, Sarah advocates for change in the finance community, actively participating in UK government lobbying and HMRC consultations to support both the finance community and business owners.

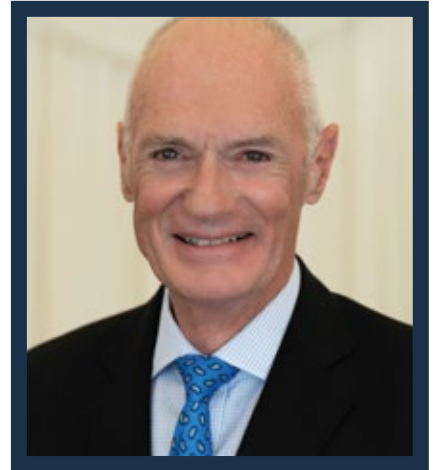
